1. Only handmade articles will be allowed to be exhibited. No costume jewelry and/or manufactured items allowed. ITEMS TO BE REMOVED WILL BE AT THE DISCRETION OF THE STREET FAIR COMMITTEE.
2. Photos must accompany your application and will be kept, if your application is not accepted for any reason your photos will be returned.
3. Exhibitors are responsible for their own tables, set-ups for their 12 ft. wide x 15 ft. long space and breakdown each day, **except for those who have paid for a secured overnight space.** Canopies or umbrellas are permitted but must not extend beyond the table.
4. Applications are due by March 1, 2019, and we expect to sell out. Applications will be accepted after the deadline if space is available.
5. The Street Fair Committee reserves the right to refuse any application.
6. If your application is accepted, there will be NO REFUNDS of the show fee for cancellations due to illness, accident or weather. Should bad weather occur please bring a tarp to protect your merchandise. Cancellation either or both days due to weather is at the sole discretion of the NBRCC
7. You must have your New Jersey Sales Tax Certificate with you both days.
8. No loud radios are allowed. Approved Generators only are permitted on Farnsworth Avenue.
9. Spaces for vendors selling food are available and it is the responsibility of the food vendor to secure electricity if needed and all documents required by the county must be submitted with registration.
10. The Street Fair Committee reserves the right to approve the sale of any food item to ensure limited duplication. The sale or service of alcoholic beverages on the street is prohibited.
11. Food Vendors using a grill must always have a fire extinguisher on site and conform to all State fire and health codes.
12. Brochures for non-profit organizations may be made available on their table.
13. Set-up is from 7AM to 9AM. **NO VEHICLES WILL BE ALLOWED INTO THE FAIR AFTER 9:00AM.** Please unload completely onto the sidewalk. Park your car and then setup
14. Cars will be allowed back on the street after 4 PM. Break down routine must be as follows: **Storage containers, which should be kept at your site, and your canopy MUST be packed and placed on the curb.** You may then retrieve your vehicle once the police re-open the street. This is to avoid traffic congestion on Farnsworth Avenue. **No breakdown is allowed before 4:00 PM.**
15. **ALL TRAFFIC MUST ENTER AT CROSSWICKS STREET EACH MORNING**
16. Entrance tags MUST be presented to gain entrance into the Fair.  
For the purpose of the Street Fair, Merchants are defined as any store fronting on Farnsworth Avenue or 2019 NBRCC members. If applications are not received by March 1, 2019, the space in front of your business will be filled! Requests received after March 1st, will be honored if space is available. This includes members and non-members.
17. Merchants and Chamber Members must sell only items normally sold in their stores. NO EXCEPTIONS! The Street Fair Committee reserves the right to prohibit any exhibitor from participating if they do not follow the above rules and regulations
18. **REMEMBER – FAILURE TO SHOW UP FOR BOTH DAYS OF THE STREET FAIR WILL DISQUALIFY YOU FROM PARTICIPATION IN FUTURE STREET FAIR SHOWS**
